It will be understood that we will make necessary enquiries, not only with the information supplied in Application for Credit, but with any Credit Bureau, Mercantile Company or supplier of our choice.

We will advise you of the results of our credit checks. Should you be granted 30 day credit terms then any delay in settling invoices beyond 30 days must be discussed in advance and agreed in every instance if collection is to be avoided.

Credit is not extended on the basis that we are paid when you are paid. We provide credit to our clients only, not to our client's clients.

CBS Printing reserves the right to withdraw credit at any time if payment terms are exceeded or adverse information becomes known.

Any claims against alleged errors or omissions must be made in writing within 14 days of receipt, any payment is required for all but the disputed portion.

All goods sold are subject to CBS Printing Credit Terms and Conditions and also to our general Terms and Conditions of Trading, and these prevail over any conflicting terms and conditions incorporated in standard orders supplied by customers.
